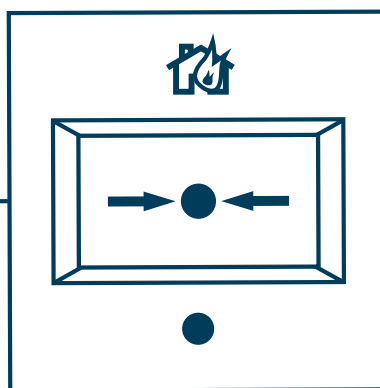

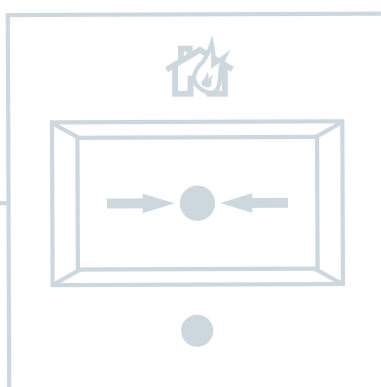

## INTRODUCTION

This Fact File has been prepared as a means to help end-users understand what they are being advised as a requirement by the Fire & Rescue Services (F&RS) under the Fire Safety Order and the CFA Unwanted Fire Signals Policy, and summarises the actions they need to take with the assistance of the Fire Trade (ie the competent person).

This document contains a checklist of areas which end users should employ to keep accurate records available for inspection by F&RS when the need arises. The check list will also assist the end users to keep their fire risk assessment and fire protection systems up to date.

## USE OF CHECK LIST

For each of the items listed in the task/action column, indicate in the appropriate box whether it is required or not for your system, and then indicate that the relative task has been actioned. A number of tasks that are required in the appropriate British Standard have been pre-ticked, as they are required for most premises.
